EXECUTIVE DIRECTOR'S REPORT

Executive Director AndI asked the Commission to consider the following resolution.

RESOLUTION NO. 2024-93

RESOLUTION AUTHORIZING UTILIZATION OF PROJECT LABOR AGREEMENTS IN PUBLIC WORKS PROJECTS PURSUANT TO REQUIREMENTS OF P.L. 2002, Chapter 44, and P.L. 2021, Chapter 69

WHEREAS, State law, including P.L. 2002, Chapter 24, as amended by P.L. 2021, Chapter 69, authorizes the use of Project Labor Agreements by the Commission, for public works projects that the Commission estimates will cost an amount that is equal to or greater than five million dollars, exclusive of land acquisition costs, and

WHEREAS, State law further authorizes the Commission's use of Project Labor Agreements for such projects where the Commission finds and determines that, taking into consideration the size, complexity and cost of the Project, it is appropriate for the Commission to award contracts to qualified public works vendors that will include one or more Project Labor Agreements meeting the requirements of Section 5 of P.L. 2002, c. 44, as amended by P.L. 2021, c. 69, whereby work on the project will promote labor stability and advance the interests of the Board in project cost, efficiency, skilled labor force, quality, safety and timeliness.

NOW THEREFORE, on this 13th day of December, 2024, be it resolved, by the Board of Commissioners of the Burlington County Bridge Commission, that:

- 1. For each contract that the Commission awards for the completion of work on eligible public works projects, each public works vendor shall incorporate an appropriate Project Labor Agreement, and the proper Commission officials are hereby authorized to negotiate and finalize each Project Labor Agreement; and
- 2. The proper Commission Officials are hereby authorized to execute each Project Labor Agreement, in an appropriate form, and upon the approval of the Commission's Solicitor; and
- 3. Each fully executed Project Labor Agreement shall be included in the bid specifications for every contract that is awarded for work on eligible public works projects, with the acceptance of the Project Labor Agreement by bidders being made a mandatory requirement of the specifications and the resulting contract.

Vice-Chairwoman Veasy moved to approve. Commissioner Woods seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2024-94

RESOLUTION CANCELLING PROCURMENT OF CONTRACT FOR RIVERSIDE-DELANCO BRIDGE, BRIDGE REHABILITATION PROJECT, BCBC CONTRACT NO. 202412

WHEREAS, the Burlington County Bridge Commission advertised for the receipt of bids for the award of a contract for the Commission's Riverside-Delanco Bridge, Bridge Rehabilitation Project, BCBC Contract No. 202412, with bids due to be received on Wednesday, December 18, 2024, and

WHEREAS, the Commission has determined to revise the specifications for the project, and to obtain related regulatory approvals for the revised project and specifications, such that the receipt of bids for the project on the scheduled date should

be cancelled, and further that the Commission intends to advertise for the receipt of bids for the revised project as soon as possible, but on a date that has not yet been determined; and

WHEREAS, under the circumstances, the Commission believes that it is appropriate to cancel the existing procurement, and the receipt of bids on the currently scheduled due date.

NOW THEREFORE, on this 13th day of December, 2024, be it resolved, by the Board of Commissioners of the Burlington County Bridge Commission, that:

1. The procurement of a contract for the above-referenced project be and is hereby **CANCELLED**, along with the receipt of bids for the project that had been scheduled for December 18, 2024.

RESOLUTION NO. 2024-95

RESOLUTION CANCELLING PROCURMENT OF CONTRACT FOR BURLINGTON -BRISTOL BRIDGE, TOWER SPANS DECK REPLACEMENT PROJECT, BCBC CONTRACT NO. 202403

WHEREAS, the Burlington County Bridge Commission advertised for the receipt of bids for the award of a contract for the Commission's Burlington-Bristol Bridge Tower Spans Deck Replacement Project, BCBC Contract No. 20243, with bids due to be received on Wednesday, December 18, 2024, and
